A RESOLUTION APPOINTING THEODORE UJFALUSSY, JR. AS A PROBATIONARY FIREFIGHTER/EMERGENCY MEDICAL TECHNICIAN (EMT)/FIRE INSPECTOR

RESOLUTION 17-08-17-67

WHEREAS, the Fire District is desirous of hiring a Firefighter/EMT/Fire Inspector to maintain its established staffing levels, and

WHEREAS, the Fire District Chief has interviewed candidates who have been certified as Firefighter and Emergency Medical Technician, and Fire Inspector, and

WHEREAS, as a result of reviewing the qualifications of said candidates and conducting interviews, it is the desire of the Fire District Chief to recommend that the individual named below be appointed by the Board of Fire Commissioners of Fire District No. 3, Township of Hanover to serve as a probationary Firefighter/EMT/Fire Inspector and serving a one (1) year probation period commencing Tuesday, September 5, 2017:

Theodore Ujfalussy, Jr.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Fire Commissioners, District No. 3 of the Township of Hanover in the County of Morris and State of New Jersey as follows:

That Theodore Ujfalussy, Jr. is hereby appointed to serve as a probationary Firefighter/EMT/Inspector effective Tuesday, September 5, 2017.

Mr. Ujfalussy will serve in a probationary capacity for a one (1) year period.

In accordance with the current 2015-2017 Collective Bargaining Agreement between Fire District No. 3 and Hanover Township Firemen's Mutual Benevolent Association, FMBA Local No. 109, Probationary Firefighter/EMT/Inspector Ujfalussy shall receive a base salary of \$48,000.00, or as determined by any subsequent and/or pending Memorandum of Agreement.

1. During the probationary period, **Probationary Firefighter/EMT/Fire Inspector Theodore Ujfalussy, Jr.**, as a newly appointed career employee, does not retain any type of permanent status within the Fire District and may be dismissed at the discretion of the Board of Fire Commissioners only after proper preliminary notice has been given allowing the employee the opportunity for a hearing before the Board of Fire Commissioners.
2. Although, **Probationary Firefighter/EMT/Fire Inspector Theodore Ujfalussy, Jr.**, shall maintain all requisite certifications issued by the New Jersey Division of Fire Safety and the New Jersey Office of Emergency Medical Services, he shall also be required to successfully complete any other training as deemed necessary and appropriate during his probationary period.

3. That certified copies of this resolution shall be transmitted to the Fire District Chief and **Probationary Firefighter/EMT/Fire Inspector Theodore Ujfalussy, Jr.**, for reference and information purposes.
