

## **March 5, 2019 Reorganization Meeting of the Board of Fire Commissioners**

### **District #3 in the Township of Hanover**

### **County of Morris, Cedar Knolls, New Jersey**

The meeting was called to order at 6:30 p.m. on March 5, 2019 in accordance with the Public Meeting Act of 1975, Chapter 231.
