RESOLUTION AWARDING CONTRACT FOR ENGINE BAY FLOOR RESURFACING

WHEREAS, the Board of Fire Commissioners, Fire District No. 3, Township of Hanover, County of Morris, State of New Jersey, identified the need for repairs, improvements and resurfacing of certain Apparatus Bay Floors, and

WHEREAS, the District as prescribed by New Jersey statute appropriated sufficient funds to undertake these repairs and improvements, and

WHEREAS, the aforementioned project was advertised for bid, and sealed bids were received, and

WHEREAS, on Tuesday, June 25, 2019 at 10:00 A.M. all bids delivered by the prescribed time were opened, in public, and have been reviewed by Bowman Consulting, and

WHEREAS, Bowman Consulting has reviewed the bids for completeness and conformity to the specifications proffered by the District relevant to this project, and

WHERAS, legal counsel to the Board, Richard Braslow, Esq. has reviewed all documents pertinent to this matter, and has found all to be in order,

NOW THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS OF FIRE DISTRICT No. 3, TOWNSHIP OF HANOVER, COUNTY OF MORRIS, STATE OF NEW JERSEY as follows:

1. Fire District No. 3 hereby awards the contract for the aforementioned project to

- 2. The sum total of this contract shall be **Fifty One Thousand Eight Hundred Dollars** (**\$51,800.00**) and
- 3. The Board shall designate a person or persons to oversee this project, to insure conformity with the project's specifications and to act as a liaison between the contractor and the Board and the architects, and
- 4. The Board shall delegate the authority to those overseeing the project to authorize any change work orders, issued consistent with the terms of the contract, and found to be necessary, and whose immediate approval is deemed necessary to maintain the timelines of the project, and

- 5. Any other change work orders deemed to have no impact on the timeline for the project shall be brought to the Board at the next regularly scheduled meeting for consideration, and
- 6. Regular reports of progress shall be provided to the Board at regularly scheduled meetings, or at appropriate and necessary junctures.
- 7. The Board shall cause to be attached hereto the successful bid document and contract for services.
