### **RESOLUTION APPOINTING A PREHOSPITAL MEDICAL DIRECTOR 2020 - 2021**

#### **RESOLUTION 20-03-03-31**

**WHEREAS**, there exists a need for a Medical Director for the Pre-Hospital Basic Life Support (BLS) intervention programs as allowed by law, N.J.A.C. 8:40 et. Seq. and 8:41 et. Seq. for the Commissioners of Fire District No. 3, Township of Hanover, County of Morris, State of New Jersey, and

**WHEREAS**, the Commissioners are desirous of making an appointment to this position, reference above, for the period 2020 - 2021, and

**WHEREAS**, funds are available or will be available for the purpose of obtaining such services; and

**WHEREAS**, the Local Public Contracts Law (N.J.S.A. 40A; 11-1 et seq.) provides that a governing body may award a contract without public advertising for competitive bidding, where the nature of said contract is in the form of a professional service, and

**WHEREAS**, the subject resolution providing for the awarding of this contract relative to professional services, and the notice of award of said contract shall be made available for public inspection, and

**WHEREAS**, the Local Public Contracts Law (N.J.S.A. 40A; 11-1 et seq.) provides that a notice of the award of said contract be published in a newspaper, said advertisement stating the nature, duration and amount of the contract.

**NOW THEREFORE, BE IT RESOLVED** by the Commissioners of Fire District No. 3, in the Township of Hanover, County of Morris, as follows:

1. **Dr. William Gluckman, 130 Speedwell Avenue, Morris Plains, New Jersey 07950** will serve as Medical Director for the District for all pre-hospital BLS intervention programs as governed by the laws of the State of New Jersey requiring medical supervision and direction, and
  2. The appointed Medical Director shall be responsible for insuring the competencies of employees delivering such care, and with maintaining conformity with said applicable State guidelines, and
  3. **Dr. William Gluckman, 130 Speedwell Avenue, Morris Plains, New Jersey 07950** will also serve to insure quality assurance of pre-hospital care, consistent with industry standards and guidelines, and
1. **Dr. William Gluckman** shall be paid on a fee for services basis for all services rendered, except as otherwise provided in the professional services agreement between said auditor and the Commissioners.
  2. Notice of this award shall be published in the official newspaper and shall be made available for public inspection.
