### **RESOLUTION 20-05-21-51**

**WHEREAS**, there exists a need by the Commissioners of Fire District No. 3, Township of Hanover, County of Morris, N.J., for compensated Emergency Medical Technicians to respond to emergency scenes as well as other needs of the District; and

**WHEREAS**, the Board of Fire Commissioners has levels of employment as compensated Emergency Medical Technicians including Full-Time, Part-Time and Per Diem, and

**WHEREAS**, the Board of Fire Commissioners has job descriptions for each of these positions as well as terms and conditions of employment, and

**WHEREAS**, the position of Interim Emergency Medical Technician exists, and the Board desires that this position is filled, and

**WHEREAS**, EMT Julia Cobleigh has been employed as a Per Diem Emergency Medical Technician, and has requested that her job status be changed to Interim Full-Time Emergency Medical Technician status effective June 1, 2020, and

**NOW THEREFORE, be it RESOLVED** by the Commissioners of Fire District No. 3, Township of Hanover, County of Morris, N.J., as follows:

1. EMT Julia Cobleigh shall assume the duties and requirements of the position of Interim Full-Time EMT effective June 1, 2020, and
2. EMT Julia Cobleigh shall be subject all policies procedures, terms and conditions of employment as established by the Fire District, and
3. EMT Julia Cobleigh shall be subject to a probationary period of not less than one (1) year from the date of this appointment, and
4. EMT Julia Cobleigh shall be subject to the return to her previous position if conditions so warrant.
