3. Probationary Firefighter/EMT Inspector David Sulpy shall have his salary adjusted consistent with the terms and conditions of the current Collective Bargaining Agreement between Fire District No. 3 and Hanover Township Firemen's Mutual Benevolent Association, FMBA Local No. 109 and shall continue to be subject to the terms and conditions and policies and procedures of the Fire District.
