 - c. Drug screening consistent with applicable State Statutes and the Policies and Procedures of the Fire District
 - d. Criminal and Employment Background consistent with applicable State Statutes and the Policies and Procedures of the Fire District

Upon successful completion of the above, the candidate shall be given an appropriate starting date consistent with the terms or conditions of employment in this job title, and any and all rules regulations and procedural guidelines and the Policies and Procedures of the Fire District and the Terms and Conditions of Employment in the referenced position.
