2. **Dziugas Reneckis, WJE Engineers & Architects, P.C., 1550 Broadway, Suite 910, New York, NY 10018** shall be paid on a fee for services basis for services rendered as per their contract with the Board.
3. This appointment is made without competitive bidding as “Professional Services” under the provisions of the Local Public Contract Law because the services to be rendered or performed are by persons authorized by law to practice a recognized profession and whose practices are regulated by law and such services are of such a qualitative nature as will not reasonably permit the drawing of specifications or the receipt of competitive bids.
4. Notice of the authorized contract award shall be published in the official newspaper within ten (10) days of its passage.
