### **RESOLUTION 23-02-16-16**

**WHEREAS**, the Board of Fire Commissioners, Fire District No. 3, Township of Hanover, County of Morris, State of New Jersey, has certain items of personal property, specifically radios and ancillary equipment, a listing of which is attached hereto, that is no longer serviceable or needed by the District; and,

**WHEREAS**, the Fire District deems that the sale of these items at public auction is not in the best interest of the Fire District; and

**WHEREAS**, the Fire District has determined that donation of these items might be beneficial.

**NOW THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS OF FIRE DISTRICT No. 3, TOWNSHIP OF HANOVER, COUNTY OF MORRIS, STATE OF NEW JERSEY** as follows:

1. The Board of Fire Commissioners, Fire District No. 3, hereby declares that the equipment described herein and enumerated in the attached documents has been deemed by the Board to be surplus property, and
2. Said Equipment enumerated in Schedule 'A' shall be donated to the Morris County Public Safety Training Academy, PO Box 900, Morristown, NJ 07963-0900, and
3. Said Equipment enumerated in Schedule 'B' shall be donated to the Huntington Volunteer Fire Company, 1 Maple Avenue, Phillipsburg, NJ, and
4. Said Organizations shall issue a Hold Harmless and Indemnification or similar document to the Fire District.
5. Said Equipment enumerated in Schedule 'C' are no longer usable and are to be discarded.
