2. **Shawn Waldron** shall, if need be, be required to attend and become certified in PHTLS within one (1) year of this appointment; course to be paid by District, attendance without compensation, and
3. **Shawn Waldron** shall be subject to a Probationary Period of no less than one (1) year consistent with the Policies and Procedures of the Fire District, and
4. **Shawn Waldron** shall be subject to the Policies and Procedures, rules, regulations and any terms and conditions of employment as established by the Fire District, and
5. **Shawn Waldron** shall be compensated at a rate commensurate with his total previous years of service as a compensated EMT.
