**WHEREAS**, the Board of Fire Commissioners has job descriptions for each of these positions as well as terms and conditions of employment, and

**WHEREAS**, EMT William Villane is currently employed in the position of Per-Diem Emergency Medical Technician, and has applied for their job title and responsibilities to be changed to Part-Time Emergency Medical Technician.

**NOW THEREFORE, BE IT RESOLVED** by the Commissioners of Fire District No. 3, Township of Hanover, County of Morris, N.J., as follows:

1. EMT William Villane shall assume the duties, scheduling and responsibilities of the position of Part-Time EMT effective September 16, 2024, and
2. EMT William Villane shall be subject all policies procedures, terms and conditions of employment as established by the Fire District for the position of Per-Diem EMT, and
3. EMT William Villane shall be subject to a probationary period of not less than six (6) months from the date of this appointment.
