RESOLUTION TERMINATING PER DIEM EMERGENCY MEDICAL TECHNICIAN WILSON

WHEREAS, the Board of Fire Commissioners continues the employment of Firefighters and Emergency Medical Technicians of the Fire District to better provide for the well-being of our communities, and

WHEREAS, by Resolution No. 26-01-08-07 adopted on January 8, 2026, the Board of Fire Commissioners appointed Christopher Wilson to serve as a Per Diem Emergency Medical Technician, effective January 8, 2026; and

WHEREAS, said appointment was expressly subject to a probationary period of no less than one (1) year, during which time the employee does not retain permanent status within the Fire District and may be dismissed at the discretion of the Board of Fire Commissioners following proper preliminary notice and the opportunity for a hearing before the Board; and

WHEREAS, the Board of Fire Commissioners has reviewed relevant information and circumstances pertaining to the probationary employment of Christopher Wilson; and

WHEREAS, after due consideration, the Board of Fire Commissioners has determined that it is in the best interest of the Fire District to terminate the probationary appointment of Christopher Wilson; and

NOW THEREFORE BE IT RESOLVED, by the Commissioners of Fire District No. 3, Township of Hanover, County of Morris, New Jersey, as follows:

1. The appointment of Christopher Wilson as a Probationary Per Diem Emergency Medical Technician is hereby terminated, effective Thursday March 5, 2026.
2. All records concerning said termination shall be placed in Christopher Wilson's personnel file and maintained in accordance with applicable statutes.
