RESOLUTION AUTHORIZING A STUDENT INTERN TO PARTICIPATE IN THE DISTRICT'S RIDE-ALONG PROGRAM

RESOLUTION 26-07-07-88

WHEREAS, Hanover Township Fire District No. 3 recognizes the value of educational partnerships that provide students with opportunities to observe and learn about emergency medical services and public service careers; and

WHEREAS, the District has been requested to host a student intern participating in a school-sponsored internship program during the summer months; and

WHEREAS, the Board of Fire Commissioners finds that participation in such a program is in the best interest of the District and the community by fostering education and career development; and

WHEREAS, the student intern shall serve solely in an observational capacity and shall not perform patient care, operate District vehicles or equipment, or engage in any duties beyond those authorized by the Chief or their designee and consistent with District policies and applicable law.

NOW THEREFORE, BE IT RESOLVED by the Commissioners of Fire District No. 3, Township of Hanover, County of Morris, as follows:

1. The Board hereby authorizes Frank Nunn to participate as a Student Intern with Hanover Township Fire District No. 3 for the duration of the school-sponsored summer internship program.
2. The Student Intern shall be permitted to ride with District personnel for educational and observational purposes only, subject to the direction and supervision of the Chief or their designee.
3. Participation in the internship is voluntary and unpaid and shall not be construed as employment or volunteer membership with the District.
4. Prior to participation, the Student Intern shall complete all required District documentation, including any school agreements, waivers, confidentiality acknowledgments, and any other forms deemed necessary by the District.
5. The Chief or their designee is authorized to suspend or terminate the internship at any time should the Student Intern fail to comply with District policies, safety requirements, or directions of District personnel, or if continued participation is determined not to be in the best interests of the District.
6. The Board further authorizes the District Administrator, in coordination with the Chief or their designee, to execute, process, and approve all administrative documentation necessary for the Student Intern's participation, including but not limited to school affiliation agreements, insurance documentation, medical clearances, liability waivers, confidentiality agreements, and any other forms or

requirements deemed necessary to facilitate participation in the District's Summer Ride-Along Program, provided all District policies and applicable laws are satisfied.

7. This Resolution shall take effect immediately upon adoption.
