RESOLUTION AUTHORIZING ADVERTISEMENT FOR BIDS

RESOLUTION 26-08-20-97

WHEREAS, the Board of Fire Commissioners of Hanover Township Fire District No. 3 has determined that exterior painting and related work is necessary for District property; and

WHEREAS, the Board desires to solicit competitive bids for the performance of such work in accordance with the Local Public Contracts Law, **N.J.S.A. 40A:11-1 et seq.**, and all other applicable laws and regulations; and

WHEREAS, specifications and bid documents have been or will be prepared setting forth the scope of work and requirements for the project; and

WHEREAS, the Board finds it to be in the best interests of the District to authorize the advertisement and receipt of sealed bids for the exterior painting project.

NOW, THEREFORE, BE IT RESOLVED by the Board of Fire Commissioners of Hanover Township Fire District No. 3, Township of Hanover, County of Morris, State of New Jersey, as follows:

1. The Board hereby authorizes the solicitation of competitive sealed bids for the Exterior Painting of District Property, in accordance with the Local Public Contracts Law and the specifications and bid documents prepared for the project.
2. The District Administrator is hereby authorized and directed to advertise a Notice to Bidders in the District's official newspaper and to take such other actions as may be necessary to solicit bids in accordance with applicable law.
3. Sealed bids shall be received and publicly opened at the date, time, and location specified in the Notice to Bidders.
4. Following the receipt and opening of bids, the bids shall be reviewed for compliance with the bid specifications and applicable legal requirements and presented to the Board for consideration and award.
5. Nothing contained herein shall obligate the District to award a contract, and the Board expressly reserves the right to reject any or all bids, waive minor informalities where permitted by law, and take such other action as may be authorized under the Local Public Contracts Law.
6. This Resolution shall take effect immediately upon adoption.
