
WHEREAS, funds are available or will be available for the purpose of obtaining such services; and

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) requires that the resolution authorizing the award of contracts for "Professional Services" without competitive bids must be publicly advertised:

NOW THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS OF FIRE DISTRICT No. 3, TOWNSHIP OF HANOVER, COUNTY OF MORRIS, STATE OF NEW JERSEY as follows:

1. Dr. George Manis will serve as Medical Advisor for the District's Pre-Hospital AED program
2. Dr. George Manis will serve as the Medical Director for the District's Epinephrine Pen program
3. Dr. George Manis will also serve in an advisory capacity involving pre-hospital care procedures and guidelines
4. This appointment is made without competitive bidding as "Professional Services" under the provisions of the Local Public Contract Law because the services to be rendered or performed are by persons authorized by law to practice a recognized profession and whose practices are regulated by law and such services are of such a qualitative nature as will not reasonably permit the drawing of specifications or the receipt of competitive bids.
5. Notice of the authorized contract award shall be published in the official newspaper within ten (10) days of its passage.
